Spring 2010 Contract Ice Information

Sessions available at the Ice Den in Hooksett NH: 10:00-10:45am

Begins Sunday April 25 to May 23 (5 weeks 45 minutes)

Ice payments are due with contract. **There will be a \$20.00 service charge for all returned checks.** Any applications received after the deadline will be processed only if space remains available. All fees are non-refundable.

The deadline for the application is April 19, 2010. Any application postmarked after April 19 will be charged a \$15.00 late fee.

PLEASE NOTE: ANY SKATER IN ARREARS MORE THAN 30 DAYS WILL NOT BE ALLOWED TO CONTRACT ICE UNTIL THE BALANCE IS SATISFIED. PER USFSA RULES THEY WILL NOT BE ALLOWED TO COMPETE OR TEST.

As always the executive board reserves the right to change any of the above sessions if they should not fill with the adequate number of skaters. You will be contacted ASAP if this should occur.

Skaters are to check in with the ice monitor before going onto the ice. Contracts must be paid in full prior to skater taking the ice.

Walk-ons: Note that SNSHC hourly ice rate with a signed contract is \$14 per hour for SNHSC Home Club members and \$16.00 per hour for non-SNHSC home club members. The walk-on fee is \$16.00 per hour for SNHSC Home club members and \$18.00 per hour for SNHSC Learn to Skate skaters and non-club members. **Walk-on fees must be paid at time skater takes the ice.**

- **Coaches are available for booking private lessons. Please call our voice mail 603-485-6144 if interested.**
- **Guest coach applications are available for NON SNHSC skating professionals wishing to teach private lessons during our ice times. Applications must be submitted prior to using the SNHSC ice times. All applications will then be reviewed and voted on by the SNHSC executive board.
